DESCRIPTION

Decorative stucco based on calcium dihydroxide.

Painting tools	: Spatula Remove as much paint as possible from the equipment in the container and clean it immediately with hot water and soap.
Conditions of application	: Do not apply at temperatures below 10°C and above 35°C.
Storage	: Store at temperatures from 5°C to 40°C. Close the container after every use.

APPLICATION

Stir well before use

Surfaces must be clean, dry and free from foreign objects and substances.

The product does not require dilution unless it's necessary.

- a) Apply a layer of PRIMER STUCCO
- b) Paint with the preferable color.
- c) 1st layer: apply one layer of STUCCO VENEZIANO of MONDO BELLO
- d) 2nd layer: after 12 hours stir to soften STUCCO VENEZIANO and apply a second layer
- e) 3rd layer: after 12 hours stir to soften STUCCO VENEZIANO and apply a third layer with irregular moves.

After we have applied on a surface of a square meter and after 30 seconds, we press and polish the surface with a stainless steel spatula. Continue in the same way on the rest of the surface.

Our wall has become glossy with a special effect.
